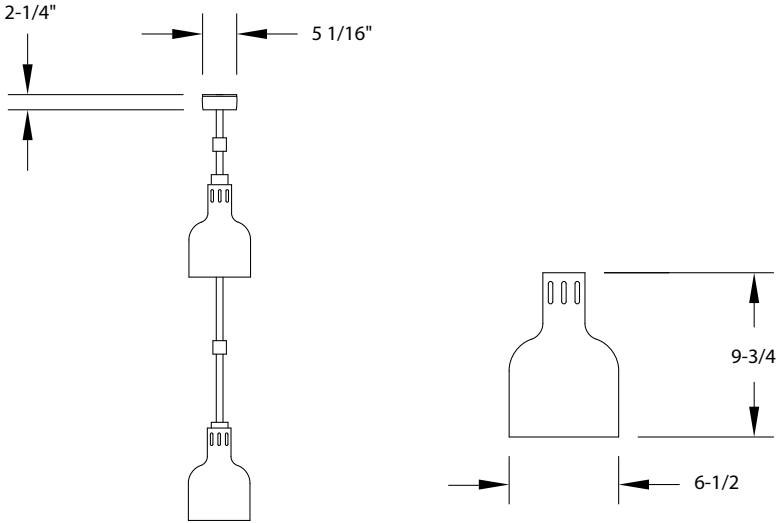

- Canopy: Spun from .051 aluminum, black anodized.
- Hanger: 16 ga. steel, 1 x 4-1/8 with slots for #10 screws; mounts canopy to customer ceiling box.
- Stem tubing: Four aluminum tubes, 5/8" O.D. x 12", black anodized; connected with aluminum couplings.
- Nipples: 1/8" I.P.S. brass plated steel.
- Switch housing: 20 ga. steel, black anodized.
- Hood: Spun from .051 aluminum; powder coat finish.
- Units shipped partially assembled.
- Install on 4" standard ceiling box.
- Do not mount closer than 16" above non-metallic surface for 250 Watts.
